

## INTERIM PRAYER



Operative portion of the Order

1. The petitioner is permitted to furnish the details of all the students along with accompanying documents by 1800 hours today which shall be considered, examined and verified by the university preferably by 24.7.2023 and the students be permitted to take up their examination on 25.7.2023.
2. In the event of the verification not being completed by 24.7.2023, the university to permit the students to take up examination subject to verification.
3. The petitioner No.2-college shall make payment of sum of Rs.25,000/- per student which shall be paid to university by 1800 hours 22.07.2023. Since the university is now made to work overtime to process the inordinately delayed submission of documents by petitioner-college, if the payment is not so made, the students shall not be eligible to take up examination.
